Skills First Victoria (SFV) Government Funding

You may be eligible for a Government subsidized training place. If you meet the citizen/residency requirements, and have not completed a Certificate III level qualification, then you are eligible for a subsidized place for the Certificate III and Certificate IV. Refer to requirements here:
